Dear Property Owner,

Due to the ongoing regulations of covid—19, We regret to inform the members of the DRPOA that our annual June meeting has been cancelled. At the time of this letter this disease is still concerning to many of our members and we are not able to comply with the mandated safety precautions.

We will try to bring you all up to date on the progress of the last physical year and offer a projection of this coming year.

Our board of directors are meeting monthly. This is working out very well, allowing us to stay on top of our business.

Last year our duly elected President and the Sergeant of Arms appointed Janet Edgin to the Vice President position and Gina Love to the Secretary/Treasurer position. These two positions will be open for election at the next spring meeting in June of 2022.

The following is a list of some of the 2020 progress:

Dam: Our volunteer work force has worked hard at clearing the trees from the north end of the dam. We had proposed to add another 10 foot to our spillway last year. This project was postponed until the summer of 2021. We have allocated \$3000.00 for this project. This money has been ear marked and is in our treasury.

Roads: We had the brush and trees cleaned out of the ditch on the north side of Dusok. This has helped with the water runoff and road erosion.

Road Grader: We have updated our road grader with used tires that were obtained from the Sharp County Road Department. The only cost to the DRPOA was new tubes and mounting. We have purchased two new grader blades and have made other repairs to the road grader.

This coming year we will be focusing on improving the conditions of our roads.
